Payments Before First 90 Day Delinquent Reported

Number of Payments Before First 90 Day Delinquent Reported Number of months paid prior to the first loan level 90 day delinquent report date. This field can only be derived when the loan is reported as a 3 month delinquency. If the loan never reaches a 3 month delinquency status, or is first reported to HUD's Single Family Default Monitoring System at a point greater than 3 months delinquent the field will be displayed as "N/A." The field is derived by subtracting the beginning amortization date plus 1 month from the date the account was first reported as 90 days delinquent by the servicer minus two months.
